## Aids Drug Assistance Program (ADAP)

**SC HIV/AIDS Activist are urging State Legislators not to reduce their HIV/AIDS Funding**

The South Carolina AIDS Drug Assistance Program (ADAP) provides access to HIV/AIDS treatments to low-income, uninsured and underinsured people living with HIV/AIDS. Authorized under Part B of the Federal Ryan White CARE Act, ADAPs are administered by each state and territory that receives federal Ryan White Part B ADAP funds. The ADAP fund pays for medication for person living with HIV/AIDS.

South Carolina ranks 8th in the nation for the rate of new AIDS cases. Columbia, the state's capitol, ranks 9th in the nation in the rate of AIDS. South Carolina AIDS cases is not decreasing. Yet, funds for the needed medication is being reduced.

According to Becky Allen, (The Body, March 24, 2010 article) Thomas Berry of South Carolina's Department of Health and Environmental Control (DHEC), is the agency that maintains the ADAP program, states, "previous years, South Carolina's ADAP was funded by a combination of state and federal money". Mr. Berry states, "this year, the proposed budget provides no state-bases funds, ADAP will continue to run on \$2.2 million from federal government, provided through Medicaid". Mr. Berry continues indicating, "this is still a serious reduction in the program's budget, which has already caused SC to close ADAP to new enrollees, and is likely to lead to the creation of an ADAP waiting list. Mr. Berry states, "DHEC plan to work with wait-listed people to help them enroll in pharmaceutical company assistance program so they won't be left without any recourse."

According to the most recent ADAP Watch report, as of March 1, 662 people are on waiting lists across 10 states —up from 346 in nine states in November. However, those number do not include everyone who was receiving ADAP coverage but had their assistance cut. Some people are not on waiting list because, due to ADAP changes in their states, they are no longer even eligible for assistance. By Becky Allen, Staff writer.

On March 17, 2010, Aids Activists lead by the South Carolina HIV/AIDS Care Crisis Task Force set to rally at South Carolina State House to "reinstate all \$5.9 millions in HIV/AIDS funding. The rally urged South Carolina's legislatures' to restore the ADAP funding for the State Aids Drug Assistance Program, as the proposed cuts will have severe and catastrophic consequences if enacted." Dr. Bambi Gaddist, Chair, SC HIV/AIDS Care Crisis Task Force states, "This is truly a matter of life or death for the thousand of people who depend upon the state to provide the lifesaving medications that enable them to lead healthy, productive lives. HIV medications can also reduce the level of infectiousness and prevent transmission of HIV from one person to another. So, this funding is also needed to help prevent the further spread of AIDS in South Carolina". Dr. Gaddis further states, "Although we understand that an amendment has been submitted to restore \$2.2 million of the original allocation of \$5.9 million, the AIDS Drug Assistance Program is receiving one hundred new application each month. If the legislature fails to fully restore funding for HIV/AIDS prevention and ADAP back in the budget, we fear that South Carolina is looking at an even greater crisis than the one in 2006 which lead to four tragic deaths".

Many people in South Carolina are without dental insurance. As a result, the demand for our dental service is continuously growing. Because of the increase in our dental demand, we encourage each patient to call to confirm their appointments. Although our appointments are booked months in advance, we try diligently to accommodate the influx of patients in a timely matter.

The Columbia Oral Health Clinic is aware and understands the urgency of **EMERGENCIES**. We make every effort to accommodate our emergency cases, as a way of helping to alleviate the pain caused by tooth aches, or other dental issues.

According to the Division of Oral Health, National Center for chronic Disease Prevention and Health Promotion (November 21, 2006). "For every adult 19 years or older, without medical insurance, there are three without dental insurance. Seventy percent of adults reported visiting a dentist in the past 12 months. Those with incomes at or above the poverty level are much more likely to report a visit to a dentist in the past 12 months; as those with lower incomes. Patients with a weakened immune systems, such as those infected with HIV and other medical conditions (organ transplant) and who use some medication (e.g. steroids)"..

We understand about the relationship with the Federal Government and their provision of dental service's for HIV/AIDS patients' and we seek

to accommodate the individual oral needs of our patients'. Oral health is one of the portals to managing overall health of every individual.

HIV-positive people should be encouraged to receive dental services every six months. HIV-positive people may develop conditions such as thrush as a result of poor oral hygiene. Most oral health problems, such as dental caries, and periodontal diseases, are the result of bacterial infections. Persons living with HIV/AIDS can protect themselves not only with routine examinations, but also by brushing and flossing regularly. Smoking and alcohol use is related to oral cancers, which are common and have a poor prognosis compared to other types of cancer.

# OUTRAGE: Dental Bill Puts Bite on Homeowner

Capri Ramos has never missed a mortgage payment on her Salt Lake City home, but after a lengthy court battle she could lose the house anyway, thanks to a \$68 dentist bill. Ramos, 43, was a young mom when she took her 4-year old to a dentist for swollen gums more than 15 years ago. Uninsured, she made partial payment and expected to be billed for the rest. But she never received a subsequent bill and soon forgot about the episode. Meanwhile, a lingering charge for \$67.72 went to collections and was brought before a judge. Ramos say she was not notified. The judge award the collections agency

hundreds of dollars and ordered the sheriff's department to sell her house to make up for the debt. The home sold at auction in 1996 for \$1,550, though Ramos had paid \$51,000 for it. It wasn't until two years later that Ramos learned on a fluke that she had lost the title to the buyer, Jarmacco Properties LLC. She paid Jarmaccc what was owed to regain the title, but the company has refused to transfer it. She's been fighting in court to regain the title ever since. "There's something immoral about how it was done," says Ramos of the sale of her home, where she still lives. "They tried to take advantage, and just because I don't have a lot of money, they thought I wouldn't fight."

### Mother's Day

Mother's Day was established by Anna Marie Jarvis, following the death of her mother Ann Jarvis on May 9, 1905, with the help of a Philadelphia merchant called John Wannamaker. A small service was held 12 May 1907, in the Andrew Methodist Episcopal Church in Grafton, West Virginia, where Anna's mother had been teaching Sunday School. The first official service was held May 10, 1908, in the same church accompanied by a larger ceremony in the Wannamaker Auditorium in Philadelphia. She then campaigned to establish Mother's day as a US National holiday, and later a international holiday. The holiday was declared officially by the state of West Virginia in 1910, and the rest of the states followed quickly. On May 8, 1914, the US Congress passed a bill designating the second Sunday in May as Mother's Day and requesting a proclamation. On May 9, 1914, President Woodrow Wilson issued a proclamation, declaring the first national Mother's day, as a day for American citizens to show the flag in honor of those mothers' whose sons had died in the war. In 1934 Presidents Franklin D. Roosevelt approved a stamp commemorating the holiday.
